Defendants.


The above-entitled matter came on for hearing, David J. Meyers appearing as attorney for the Petitioner, on May 4, 2007, at the Stearns County Courthouse in St. Cloud, Minnesota, before the undersigned Judge. It appears to the Court that all requirements of Minnesota Statute Section 465.79 and other applicable law have been complied with, and all of the Defendants in this proceeding have been duly served with process as required by law and prior Orders of this Court, and further appearing that no Answer or Notice of Appearance of any kind has been served or filed in said proceedings.

IT IS SO ORDERED, that a default as to each and every Defendant described in the Petition and any amendments or supplements thereto and all heirs and devisees of any of the persons named therein who are deceased and all other persons or parties unknown claiming any right, title, estate, lien or interest in the real estate described in the Petition and Boundary Commission Plat, be and the same is hereby entered.

The Court having duly considered the Petition, and the evidence adduced by the Petitioner in support of its right to this Order, and being fully advised in the premises, finds that the Petitioner has had the land involved herein surveyed by Kramer Leas Deleo, as evidenced by the Boundary Commission Plat, which has been filed herein showing the boundary lines of said Plat claimed by the Petitioner and that said boundary lines are as shown upon said Plat.

IT IS THEREFORE ORDERED, that the Petitioner proceed to have said Surveyors mark said boundary lines by placing Judicial Landmarks, and a Plat of said survey showing the location of each said Judicial Landmarks, certified as to location thereof by the Surveyor and by the Stearns County Surveyor's Office, be then filed herein.
